Superior Tanker Shuttle Service - Accredited

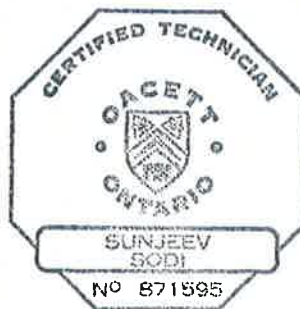
I am pleased to advise you that the above mentioned fire protection area within the province of Ontario was recently registered in the fire insurance grading index as being reaccredited for the delivery of Superior Tanker Shuttle Service. On October 23, 2012, the Fire Department successfully demonstrated their ability to meet Fire Underwriters Survey Alternative Water Supplies for Public Fire Protection protocol.

The requirements for this accreditation are stringent and verify that the fire protection district is capable of delivering the minimum accepted fire flows to detached dwellings throughout the fire protection district within 8 kilometres by road of the responding fire station and 5km by road of a water supply point conforming to NFPA 1142 – Standard on Water Supplies for Suburban and Rural Fire Fighting, *recent edition*. This accreditation is an equivalency to the minimum requirements for hydrant protection as set out by the insurance industry and the Fire Underwriters Survey. Dwelling Protection Grade 3B(S) should be applied to properties insured under Personal Lines that are within 8km road distance from the accredited fire hall and 5km of a water supply point as outlined.

Fire Underwriters Survey has provided information on fire protection and risk levels to the insurance industry in Canada for more than 100 years. Fire Underwriters Survey was originally operated under the auspices of the Insurance Advisory Organization until 2002. Fire Underwriters Survey is now operated by Opta Information Intelligence.
